



Terms of Participation

All references to persons refer to both men and women.

1. Acceptance

By signing the terms of participation the student (hereinafter participant) who is applying to participate in one of the events organized by Pro IYPT-CH as well as the parents or legal guardian (hereinafter guardian) agree to the following points.

2. Registration and Withdrawal of Participation

The registration for the chosen event organized by Pro IYPT-CH is valid by filling out the registration form and sending in the signed terms of participation.

After the registration deadline the participant may only withdraw his participation in case of an unforeseen event. Short-term cancellations lead to expenses for Pro IYPT-CH. Therefore Pro IYPT-CH has the right to ask students who withdraw their participation less than four weeks before the event for a contribution towards expenses up to CHF 250.-.

Participants chosen to represent the Swiss team at international events (IYPT or IYNT) are aware of the fact that the preparation can be intense and time-consuming and are willing to dedicate their time and effort to the preparation.

3. Publication and Intellectual Property

The participant agrees not to publish his results before the end of the international tournament. All participants recognize that publishing or posting their results, presentations or segments of their presentations before the end of the international tournament could eventually benefit other teams. The participants are therefore asked to act reasonably and maintain confidentiality.

The participant agrees to respect the intellectual property of his team members. This includes but is not limited to neither publishing nor giving access to results, solutions and presentations of the other team members to third parties.

4. Media

Pro IYPT-CH is dependent on a broad public perception and media attention. The participant gives Pro IYPT-CH the right to publish his name, place of residence and residential canton in media releases.

In case of an interview request (newspaper, radio, television or others) Pro IYPT-CH has the right to share contact details of the participant.

5. Pictures and Videos

The events organized by Pro IYPT-CH will partially be documented through pictures, video and audio recordings.

The participant gives Pro IYPT-CH the right to publish pictures, video and audio recordings on the official SYPT and SYNT homepage, on the SYPT and SYNT Facebook page and group, on media releases and printed material released by Pro IYPT-CH as well as in national and international press articles, as long as the topics covered are related to the SYPT or SYNT.

6. Insurance

The participant is required to possess the necessary insurance coverage. All insurance matters regarding his person lie in the responsibility of the participant. This includes, but is not limited to health care insurance and indemnity insurance.

The participant agrees to inform the team leaders about medical conditions or allergies which require special attention in case of an emergency. This information will be treated strictly confidentially and is requested to ensure the safety of the participant.

Pro IYPT-CH accepts no responsibility for loss, theft or damage of participants' property. Participants should take care of their possessions at all times.

7. Liability and Responsibility

The guardians acknowledge that Pro IYPT-CH cannot guarantee a full-time supervision of the participants during the events.

Therefore, the participants are expected to behave appropriately and follow the rules of local organizers, cultural customs as well as the local laws during all events organized and attended by Pro IYPT-CH. They agree to respect and follow the instructions of organizers and supervisors.

8. Law

Swiss law is exclusively applicable and place of jurisdiction is Zurich.
